

## AUTHOR GUIDELINES FOR EUGEO2013 EXTENDED ABSTRACT

**Requested format:** Word document (.doc) *and* Acrobat (.pdf)

**Languages:** English or French. If the language is not the author's mother tongue, the text, including the abstracts, must be revised by a native speaker.

**Abstracts:** Abstracts must be supplied in English or French. Total number of words should not exceed 250. The abstract should contain a brief description of the purpose, the theoretical and methodological framework, the contents and results of the work.

**Key words:** Three keywords should be entered in English or French.

**Length:** Contributions should not exceed 6000 words.

### **Style:**

Articles should be edited according to the author guidelines of the Rivista Geografica Italiana (<http://www.rivistageograficaitaliana.it/english/pubblicare.html>), and particularly:

1. Articles should be divided into sections and if necessary into sub-sections titled and numbered sequentially, for example:

5. TOURIST FLOWS IN NAPLES - Text...

5.1 *Changes in the typology of tourism supply* - Text...

2. Footnotes should be minimized and used to explain or illustrate details that is not possible to include in the main text. They should be placed at the bottom of the page with the reference between brackets in normal position (both in the text and in the footnote), for example: (1) For more detailed information see...

3. Figures must be numbered sequentially with Arabic numerals, and the heading and any source must be reproduced below the figure, for example:

4. Tables must have the title above the table, in small caps and with Roman numerals, for example:

Tab. III – TOURISTS IN CAMPANIA

[TABLE] *Source:* ENIT

5. Bibliographic references should be dealt with as follows:

a) in the text and footnotes, by typing in parentheses the last name(s) of author(s), followed by the year the work was published and if necessary the relevant page or pages, for example: (Wenzel, 1971); (Toschi, 1959, p. 37); (Ibid., pp. 38-41): to indicate the immediately preceding reference with different pages; (Ibidem): to indicate the immediately preceding reference with the same page(s).

b) at the end of every article or survey, with an alphabetical list *in extenso* of all bibliographical references cited in the text and footnotes. Reference citations should be in the following form:

– References to books: MITCHELL D., *Cultural Geography. A critical introduction*, Oxford, Blackwell, 2000.

– References to articles or contributions to journals: MCDOWELL L., “Towards an Understanding of the Gender Division of Urban Space”, *Environment and Planning D: Society and Space* 1(1), 1983, pp. 59-72 (issue number in Arabic numerals, year in Arabic numerals, any part number in Arabic numerals, page numbers must always be given).

– References to chapters in edited books and proceedings: PECK J., TICKELL A., “Searching for a new institutional fix: the after-Fordist crisis and the global-local disorder”, in AMIN A. (ed), *Postfordism: A Reader*, Oxford, Blackwell, 1994, pp. 280-316 (page numbers must always be given).

6. Acronyms should be given in small caps with an initial capital (e.g. UNESCO); italic should be used only for foreign/archaic words not in current use; quotations and highlighting of terms should be in quotation marks “ ”; bold should never be used. Capital letters should be used sparingly and consistently, not for common terms and only for the first word in an expression (e.g.: International geographical union).

7. Authors are requested to indicate at the end of the text: a) the department, laboratory, company etc. in which the work was carried out, with detailed address and author’s email; b) whenever available, the funding source supporting the research.

**Submission:** the extended abstract must be sent to [extendedabstract@eugeo2013.com](mailto:extendedabstract@eugeo2013.com) before July 21<sup>th</sup> 2013.

**Publication:** the extended abstract will be downloadable from the Eugeo 2013 website ([www.eugeo2013.com](http://www.eugeo2013.com)) as a pdf attachment and *will not* published in book form. When submitting their extended abstract, authors give consent to it being freely distributed in non-published form and *are not* asked to transfer the copyright of their work.
